## Processing personal data

Nude-thinking Counseling processes your personal data after your use of the services offered and because you provide this information on request and with permission. The information you provide is:

## Specific and sensitive information

Specific and sensitive information about your coaching goals, your process and your health will be captured during a consultation, this is done in a mindmap and/or typed out. Conversations shared in e-mail exchanges are added to your file. Online sessions will not be taped unless specifically requested by the client, if so than the taping will become part of the client file. A digital invoice is sent, which contains your personal details, name/address/postcode/place of residence. Alternatively a Paypal or 'Tikkie' payment request is made.

## Purpose data

Your data will only be used for your coaching process with the corresponding handling of the payment. Your phone number and email address will be listed to contact you in the event of an cancellation or change of appointment. The employer's data is used to draw up a quote for a tailor-made coaching process with a financial settlement as well.

## **Retention period data**

Nude-thinking Counseling has a retention period of 20 years for your file, the tax data have a retention period of 7 years. This is the legal retention requirement for health records and its components. After each term, the data, in writing and digitally, will be destroyed.

These include:

- Data coaching process (20 years)
- Personal data (7 years)
- Email address (7 years)
- Phone number (7 years)

## **How your data is protected**

Your details, written notes included, will be added to your file. Which are kept in a closed unit. Your data that is digitally processed is stored in a digital file in a password-protected computer. This computer is protected with a strong password and is updated regularly for virus and data breaches.
